MOTION OF SOUTH AFRICAN AIRWAYS TO SHORTEN TIME FOR ANSWERS

Pursuant to Rule 311(a) of the Department's Rules of Practice, South African Airways (Proprietary) Limited d/b/a South African Airways ("SAA") moves to shorten the time for filing answers to its application in the captioned docket to and including August 9, 2000. In support of this motion, SAA states as follows:

1. The captioned application seeks to restore nonstop air service between Nigeria and the U.S. by adding Lagos, Nigeria as an intermediate point for SAA's service between the Republic of South Africa ("RSA") and the U.S. SAA plans to operate the first promotional flight, carrying revenue passengers, on August 15, 2000 between Lagos and New York. The 15-day exemption application response period set forth in Rule 307 would not give the Department sufficient time to consider the application.

The underlying agreement with Nigeria Airways was initialed on Friday, August 4, 2000. The docketed application was filed as promptly thereafter as possible.

responses and replies, if any, before the commencement of service on August 15. The

answers to its application in this docket be shortened to August 9, 2000, and that the Department

grant such other relief as it deems appropriate.
